## **Coalition Updates**

#### Gathering of Native Americans (GONA)

 Cristian Canales reported out – We had 3 youth summer camps all throughout June and July. During the Living in 2 Worlds summer camps, we hosted a youth GONA is the afternoon. For our summer camp at Clarendon Elementary, we had 15 youth complete our June GONA and 17 youth complete our July GONA. We also completed a Youth GONA at Guadalupe for the Pascua Yaqui tribe's Flight 33 program with 16 youth finishing.

#### Living in 2 Worlds

 Jolene Fernandez reported out – Living in 2 World is our evidence-based curriculum and we host 2 camps in the summertime, one in June and July. Our June camp was very successful, we had 16 youth graduate, and some were returning students, so it was nice seeing them reconnect with their L2W friends. Our July camp was also successful and interactive with 16 youth. We had cultural workshops; our elder program was incorporated and gym activities. We also finished a cycle at Flight 33 with the Pascua Yaqui tribe in Guadalupe with 6 youth completing.

#### **Parenting in 2 World**

• Ethan Tsosie reported out - We completed a Cycle 13 on July 1<sup>st</sup> with 3 finishing. Our ongoing cycles are Cycle 14 & 15 will finish soon with a total of 8 parents. We are currently recruiting cycles for the new fiscal year with a variety of different dates to accommodate the different schedules parents have.

#### Parenting Classes w/ ASU Global Center for Applied Health Research (GCAHR)

- Loren Bahe reported out We have a GCAHR cycle beginning on July 11 that will be taking place at Native Health Mesa and will continue every Thursday evening. We are seeking guardians who self-identify as American Indian or Alaska Native (AI/AN) who are caregivers for an AI/AN youth ages 12-17. Another cycle happening in September.
